The purpose of the “Pulling Back the Curtain”: Addressing Inequity in the Overdose Crisis webinar is to increase awareness among prescribers in the current inequities that impact the outcomes of individuals living with Opioid Use Disorder (OUD) and how to address those inequities in practice. This 1.5-hour webinar session will be led by Rush Substance Use Disorder - Center of Excellence Director, Tanya Sorrell.
